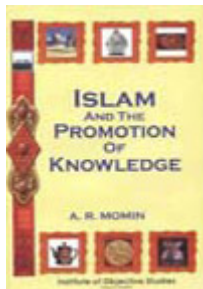


Maintenance Rights of Muslim Women
