The above Table shows that in different states:

- Bribe given "Several times + Once or twice" ranges from 20% (Goa) to 78% (Rajasthan) being 75% in Bihar and 74% in Jharkhand and UP.

- Bribe given to "Police" varies from 0% (Goa, Odisha and Uttarakhand) to 45% (West Bengal) with 41% in Gujarat.

So, it is evident that "Corruption" is prevailing all over India.
